

## **Betfury.io Terms and Conditions**

### **1. General**

- 1.1 The Service is owned by Universe B Games B.V., a limited liability company registered in Curacao with company registration number 155126, with registered address at Curaçao , Rooi Catootje 88 (“Company”), licensed in Curaçao under the Licence 365/JAZ Sub-License GLH-OCCHKTW0712232020 issued by Gaming Services Provider N.V. for the provision of online games of chance.
- 1.2 These T&C should be read by you (the "User" or "you") in its entirety prior to your use of BetFury’s Service or products.
- 1.3 Before registering an account you must carefully read these Terms & Conditions. If you don’t agree with at least one clause then you should not continue to use the Website.
- 1.4 These T&C enter into force as soon as you register an account. By completing this, you make it clear to betfury.io that you have read these T&C and accept them.
- 1.5 The player must be aware that he is obliged to comply with all established T&C of the website and carefully monitor changes and/or additions that may be made by the site administration in the user agreement.
- 1.6 We reserve the right to change this policy at any given time, of which you will be promptly updated. If you want to make sure that you are up to date with the latest changes, we advise you to frequently visit this page.

### **2. Authority to use BetFury’s Services:**

You may use the website and participate in the Games offered on the website if:

- 2.1 You are over 18 years old or such higher minimum legal age of majority as stipulated in the jurisdiction of Your residence;
- 2.2 I-gaming and online betting are allowed in your region. We are not responsible for violation of any local laws related to online i-gaming restrictions.

### **3. Your member account**

#### **3.1 Your Account Registration**

- 3.1.1 You must be registered and open an account in order for you to be able to place wagers using any of the Website.

3.1.2 While registration you will have to enter your email and password for your login into the Website. It is your sole and exclusive responsibility to ensure that your password details are kept securely. You must not disclose your password details to anyone.

3.1.3 Betfury.io doesn't allow any kind of robots and programmed devices to participate in game play. betfury.io reserves the right to void any game play which results from the use of robots and/or programmed devices.

### **3.2 Deposits on your Account**

3.2.1 To use the website and Games you must have sufficient Virtual Funds on your account.

3.2.2 To deposit Virtual Funds into your account, you can transfer Virtual Funds from your personal wallets or other Virtual Funds related accounts.

3.2.2 Ability to use our website and play Games is available as soon as the transaction has been completed.

### **3.3 Withdrawals from your Account**

3.3.1 Withdrawals shall be made to your wallet address.

3.3.2 You should not withdraw money that was wrong credited to your game wallet, and if you do so, this amount will be the debt owed by you to us. In the case of an incorrect crediting (for any reason), you are obliged to notify us immediately by email.

3.3.3 The users are fully responsible for paying all fees and taxes applied to their winnings according to the laws of the jurisdiction of the player's residence.

## **4. Your representations and authorities**

You hereby declare and warrant, covenant and agree with the following:

4.1 Your use of the Service is at your sole option, discretion and risk;

4.2 You participate in the Games and Services only on behalf of yourself;

4.3 All information that you provide to betfury.io during the validity of this agreement is true, complete, and correct. You shall immediately notify us of any change of such information;

4.4 You take on the risk of losing the funds deposited in your account by using the Service;

4.5 You are solely responsible for any applicable taxes or other amounts payable in your resident country which may be payable on cryptocurrency awarded to you through your using the Service;

4.6 You are aged 18 or over or above the minimum legal age of majority in your jurisdiction. Thus you confirm that you are legally allowed to use the Service under the relevant laws in your jurisdiction.

## **5. Privacy Policy**

5.1 By using the website, you agree to provide your personal data to betfury.io in order to have the access and use the website. We may review the Privacy Policy periodically and reserve the right to change the Privacy Policy at any time at our discretion by posting such changes on the website.

5.2 BetFury is committed to secure your data and keep it confidential. BetFury has done all in its power to prevent data theft, unauthorized access, and disclosure by implementing the latest technologies and software, which help us to safeguard all the information we collect online.

5.3 BetFury will not lease, sell or distribute your personal information to any third parties, unless we have your permission. We might do so if the law forces us. Your personal information will be used when we need to send you promotional materials if you agree to this privacy policy.

5.4 We are collecting your data for several reasons:

5.4.1 To better understand your needs;

5.4.2 To improve our Services and products;

5.4.3 To send you promotional emails containing the information we think you will find interesting;

5.4.4 To contact you to fill out surveys and participate in other types of market research.

5.4.5 If you win a sum as worthy of publicity, you agree to make yourself available for any event of such nature arranged by betfury.io. We reserve the right to use your nicknames in any BetFury announcement about promotions or competitions results on the website or our social networks.

## **6. Limitation of liability**

6.1 You participate in the Games at your own risk. There is no warranty regarding the use of the Website and the Games provided by us.

6.2 Under no circumstances, betfury.io, Games, Services or the Website do not warrant:

6.2.1 that the software or the Website is/are fit for their purpose;

6.2.2 that the software and Website are free from errors;

6.2.3 that the Website and/or Games will be accessible without interruptions.

6.3 We are not liable for any damages, expenses, or losses which may or may not have arisen from the use of our services.

6.4 Bets and any winnings received during a malfunction in the game are invalid.

Any subsequent Games or Services in which you participate for the funds received from the malfunctioning game will also be invalid

## **7. Complaints**

7.1 In case of any complaints regarding our services you may contact our customer service support@betfury.io

7.2 Our support works 24/7. Feel free to contact us if you have any wishes or questions about the platform via Live support.

7.3 When we wish to contact you regarding a dispute, we will do so by using any of your Contact Details.

7.4 Disputes and complaints regarding users' gaming activities, platform functionality mechanics, and others related to the platform and user interaction are able to be reviewed no later than 14 days after the issue took place.

## **8. Assignment**

BetFury reserves the right to assign a part of this agreement or in whole at any time without notice. You may not transfer or assign this agreement in any way.

## **9. Multiaccounts**

Betfury website allows User's personal use. We highly recommend using the Service for personal purposes and entertainment. Creating multiple accounts for the purpose of collusion, fraud, Service abuse, and/or any kind of Service manipulation is prohibited and may result in account closure.

## **10. AML Policy**

Betfury prohibits and rejects the use of the Service for any form of illicit activity, including money laundering, terrorist financing or trade sanctions violations. Accounts suspected of Money Laundering by using Service may be blocked and transactions may be stopped until the Risk department will finish all the required procedures.

According to Betfury AML policy, all crypto deposits must meet a basic rollover requirement. A rollover means that all users must do 100% wager from the coming deposit before a withdrawal can be done.

That means if your deposit is 300\$ in ETH, for example, you should wager at least 300\$ in ETH before withdrawal may be enabled. This rule applied to every User's cryptocurrency balance separated.

The Betfury Risk department is eligible to stop every suspicious transaction to prevent money laundering. Users' accounts may be under investigation by the Risk department until all requirements will be met, payment in time of investigation will be stopped.

## **11. Know your Customer (“KYC”)**

Betfury reserves the right, at any time, to ask for any KYC documentation if it is necessary. Betfury reserves the right to restrict the Service, deposit, or withdrawal until identity is sufficiently determined, or for any other reason in Betfury Risk Department discretion.
